PROPOSED BY-LAWS SET FOR VOTE

Main topic of discussion at the July 17 General Meeting was the proposed new by-laws. Several changes were suggested, and these have been incorporated into a revised proposal. In order to reach as many Association members as possible, each homeowner should be receiving by mail a copy of the proposal, along with an absentee ballot.

Please review the by-laws and return your absentee ballot as soon as possible, but no later than Friday, September 14.

The ballots will be collected and counted by homeowners who are not

members of the Executive Committee or related to them. Results will be presented at the Executive Committee meeting scheduled for Tuesday, September 18. If you would like to help with tallying the votes, contact Sheree Speck.

Also at the September 18 meeting, an **Officer Nominating Committee** will be named. Volunteers are also needed for this committee! You may come in person to the meeting or notify Sheree Speck if you would be willing to help nominate officers or to serve as an officer yourself.

ARE THEY PART OF THE CIVIC ASSOCIATION OR NOT?

There is often confusion about the status of the commercial property facing Campbell Road, between Long Point and Willowview Lane. Although these properties fall within the boundaries of Spring Branch Oaks subdivision, they are not subject to the deed restrictions, as is the residential property.

According to the SBOCA Deed Restrictions, these commercial properties may be used only for businesses that traditionally support a neighborhood. Expressly forbidden are sexually oriented businesses, and the occupants must

comply with all City of Houston ordinances. The Association also reserves the right to approve buildings and businesses that can be placed on the commercial lots.

Beyond the definition of commercial property, Spring Branch Oaks Civic Association has no authority over the businesses located on these lots. When disputes arise between SBOCA homeowners and the commercial residents, complaints to the city or to the police **can only be made** by parties directly affected.

FREE FIRE ALARMS TO BE GIVEN OUT
