NEW BY-LAWS AND BOARD ARE VOTED IN

By-laws ratified

The proposed new By-laws for Spring Branch Oaks Civic Association - designed to bring our association into compliance with state laws and to streamline its operation - were ratified by homeowners in September. These By-laws govern how our organization operates.

The Deed Restrictions, which govern how our property is maintained, are unchanged.

Both these documents, along with the guidelines for various outdoor features, are available on the association's website, <u>www.springbanchoaks.com</u>.

One feature of the new organization is a change from one-year terms for officers elected to specific positions, to staggered three-year terms for members of a Board of Directors, composed of three to five members.

The offices of president, vice-president, secretary, and treasurer will be filled by members of the Board. Election of the officers will be held at the first board meeting on Tuesday, January 8. (This is similar to the way in which Spring Branch ISD school board operates.) The initial board members will stagger their terms for one, two, or three years.
